# Lecturer/Instructor Experience

Preceptor (History/Political Science), Master of Arts Program in the Social Sciences (MAPSS), University of Chicago, 2016-18. Preceptors guide 18 MA students from orientation through convocation, provide course advice, teach "Perspectives in Social Science Analysis," a graduate survey of major research paradigms, lead an MA proposal workshop, and serve as the second reader on 18 MA theses. Preceptors also participate in MAPSS admissions and student recruitment.

I lectured weekly to 75 students on Japan's gender roles and racism in electoral politics, economic development, and evolving parliamentary-cabinet system, crises management, and post–Cold War nationalism and relations with China. Additional responsibilities included grading and commenting on students' weekly response papers, holding office hours, and providing guidelines for writing final-exam papers.
